## GENERAL TERMS OF AGREEMENT

To qualify for wholesale purchases, you must be a valid retail business and by agreeing to our terms and conditions you certify that you are such. You are only authorized to sell through the retail store that you have listed. Secondary stores, as well as website and online sales must receive prior written approval.

## ORDER REQUIREMENTS

We ask that you purchase a minimum quantity of 20 of the units of each product.

Due to limited stock, we ask that you do not order more than 50 units of the same product without prior approval in order to respect production and shipping deadlines.

Due to high demands for the Christmas season, all orders for this specific period must be placed before November 15<sup>th</sup> during any given year. We can't guarantee our usual delivery time if an order is submitted after this deadline.

## PAYMENT INFORMATION

We accept payments via PayPal or Check for all wholesale orders.

Orders must be pre-paid; we are not able to offer standing accounts. You will be emailed the invoice for the unit and will have 3 days to pay invoice.

Please note after 3 days of an unpaid invoice, invoice will be cancelled. We will then reallocate resources for other orders, which may cause a delay in your shipment. No orders will be processed until full payment is received.

We reserve the right to alter our prices at any time unless prior invoiced.

## SHIPPING & HANDLING

The retailer incurs the shipping costs, but Ash & Ivy will insure packages with the carrier. Shipment occurs within 10 to 14 days of production. This does not include weekends and holidays. Delivery date is based on carriers' discretion. We use USPS, based on cost affordability.

If your shipment is damaged in transit you agree to contact Ash & Ivy within 2 days of delivery. Any problems must be reported in writing or by email along with photos. Retailer cannot return goods without written authorization.
